



## **Part-Time Occupational Therapist: Early Intervention Wonderland Child & Family Services**

**Overview:** Wonderland Child & Family Services is a nonprofit agency providing support and therapeutic services for children ages birth to three with developmental delays and disabilities and their families, as well as birth through age 12 services to children with prenatal substance exposure. This position is responsible for providing evaluation and educational support services for enrolled children who are delayed or disabled in a manner impacting their development, thereby reducing the impact of the child's diagnosis or delay on their skills and abilities. Provide coaching, consultation and training services for caregivers of children enrolled. Be an active participant in our transdisciplinary team of therapists, educators, and family resources coordinators.

### **Chief responsibilities:**

- Assess and evaluate each child's performance in all areas of development using instruments and a timetable approved by the agency.
- Participate in the development of each child's Individualized Family Service Plan (IFSP).
- Provide direct and indirect services to children with developmental delays or disabilities in their natural learning environments.
- Provide coaching and consultation for staff, parents and care providers.
- Attend or conduct conferences/consultations with caregivers.
- Participate as a member of the transdisciplinary team including caregivers and professional staff.
- Serve as a liaison with the medical and educational community on behalf of enrolled children and their parents/caregivers.
- Demonstrate a caring, nonjudgmental attitude with every family.
- Attend scheduled clinical and staff meetings and be an active participant in staff related activities.
- Prepare written reports and chart notes as required by WDC.
- Provide in-service trainings of staff and volunteers as needed.

### **Requirements/Qualifications:**

- Valid OT license in state of Washington.
- Training and/or experience in sensory assessment and treatment.
- Feeding experience preferred.
- Valid driver's license, current insurance and reliable automobile required.
- At least one year of working with young children (0-3) and families preferred.
- Bilingual preferred.
- Able to work at a center, in a family's home, and in a variety of community settings.
- Physical requirements – able to participate in active floor time including sitting, standing, walking and lifting up to 50 pounds.
- Current criminal background check maintained for all employees.
- Effective verbal and written communication skills.
- Strong organizational skills.
- Valid driver's license, current insurance and reliable automobile required.
- Wonderland employees are mandated reporters of any suspected abuse or neglect of a child to either DSHS or law enforcement.
